ADDITIONAL CONDITIONS OF THIS AGREEMENT:

1. Privacy Act (FERPA)—All students at Florida College are considered **dependent** regardless of age or living arrangements unless **written evidence** is provided to determine otherwise. Parents or legal guardians of dependent children have full access to the student's academic and financial information.
2. Payment of base tuition, room & meal plan charges, activity and technology fee is required prior to orientation each semester. Completed and approved student financial aid for loans, grants and scholarships will be applied to these charges. Registration for courses at Florida College will be official when all financial obligations are met. **To ensure your student's registration not be interrupted, all payments should be remitted by July 1 for fall semester and by Dec. 1 for spring semester.**
3. The college recommends that applications for financial aid (loans, grants, scholarships and work requests) be completed by May 1 for admission to the fall semester. If there is a balance remaining after financial aid has been expended, payment may be made in the form of cash, check, money order, VISA, MasterCard, or Discover Card. All payments must be made in US currency.
4. Any additional charges incurred during the semester should be paid upon receipt of the next billing. The college reserves the right to change fees and charges without notice.
5. All purchases from the Florida College Bookstore must be paid for at the time of purchase. Students may charge bookstore items to their account if the student's account has a credit balance of at least \$250 prior to the time of purchase.
6. Unpaid accounts that are more than 30 days past due are subject to the following:
 - a. The account will be considered delinquent and will accrue interest at 18% APR.
 - b. The student may not be able to register for the subsequent semester.
 - c. The account may be turned over to a collection agency and subject to additional collection fees, up to 50% of the outstanding balance.
 - d. The account may be reported to credit reporting agencies and appear on the credit report of all responsible parties.
 - e. The student may be suspended from Florida College.
 - f. Unpaid meal plan fees will result in suspension of meal plan privileges.
7. Florida College will NOT release final grades and/or transcripts until balances are paid in full.
8. Persons signing this agreement are responsible for making sure all Financial Aid requirements including applications for grants, loans, veteran's aid and scholarships of all types are completed and approved before registration.
9. In the event the student withdraws or is suspended, the balance due will be paid immediately after all credits and/or adjustments, if any, are applied to the student's account. Please refer to the Florida College handbook for pro-rata calculations.
